Northern Light Acadia Hospital's Maine Rural Dementia Training Project
MAPP member Cliff Singer MD writes:

Acadia's Mood and Memory Clinic is leading faculty from across the state in an ambitious project funded by a large grant from the federal agency, Health Resources and Services Administration (HRSA). The project will provide lasting benefit to people in Maine with cognitive disorders and dementia. The primary objective is to give the medical community the training and resources they need to reduce reliance on and wait time to see geriatric psychiatrists, neuropsychiatrists, geriatricians and other dementia specialists. There are many elements to the project, including the creation of a PGY-5 neuropsychiatry fellowship for psychiatrists and neurologists.

Two opportunities for learning funded by our grant may be of special interest to you: The University of New England's Annual Geriatric Conference in Bar Harbor May 21-22 at the Harborside Resort will feature a core curriculum in mild and major neurocognitive disorders on the second day of the conference, Thursday May 22. The faculty includes leading geriatric psychiatrists and geriatricians from several of Maine's health care systems. A second conference will take place at the Wells Conference Center on the University of Maine campus on Friday June 13th. This conference will feature special topics and case-based learning and discussion. Low-cost conference-rate rooms are reserved at the lovely new and historic Hotel Ursa, right on campus. CME are available for both conferences. And both are no cost to students and residents.

We truly hope to see MAPP members at one or both events.
